MINUTES OF THE MISSISSIPPI GEOLOGICAL SOCIETY

The first fall meeting of the Mississippi Geological Society was a dinner meeting at the Edwards Hotel at 7:30 P.M., October 4, 1945. Twenty-six members were present for the dinner, and an additional five members were present for the business meeting.

Following the dinner Mr. Frederic Mellen, Vice-President, presiding in the absence of President J. B. Storey, called the meeting to order.

The minutes of the last meeting on May 17, 1945, were read by the Secretary-Treasurer and were approved by the Society.

Mr. Mellen informed the Society that many members who had been contacted, and who were expected to attend the dinner, were absent, and the Society was financially responsible to the Hotel Management for reservation vacancies. Members attending were called upon to express their opinion regarding future dinner reservations. After a lengthy discussion by various members, Mr. Spooner made a motion, which was seconded and approved, that henceforth any member of the Society making a dinner reservation would be held responsible for the reservation, independently and financially, unless the program chairman was notified in sufficient time before the scheduled dinner to cancel that member's reservation.

Mr. Mellen then read the names of the following new members into the Society:

Mr. Mellen then asked for reports from the following committee chairmen:

1. Program Committee

In the absence of Mr. Sherwin, Chairman,

Mr. Mellen read a letter from Mr. Sherwin pertaining to prospective speakers to appear before the Society during the year.

Mr. Murray discussed this subject in detail.

2. Nomenclature Committee

Mr. Toler reported the Committee had designated the following names for newly discovered fields, salt domes, and new producing sands:

New producing sand in the upper Tuscaloosa at Heidelberg.
- D. Brumfield Sand
New producing sand in the Eutaw at Tinsley.

3. Field Trip Committee

Mr. Spooner announced that the Society would

sponsor a field trip covering the Eutaw and Tuscaloosa sections in Western Alabama, December 7th and 8th, in cooperation with the U.S.G.S. and the Alabama Geological Society. Mr. Spooner advised that guide books covering all phases of the trip were being prepared, and structural and areal distribution maps would be included.

The price to be set for this guide book was discussed. Mr. Hughes's suggestion that the charge be such to fully cover all expenses of publishing, plus a reasonable profit to support future worthy expenditures of the Society, was met with general approval of the Society. The price to be set would necessarily have to be made at a later date.

4. Cretaceous Committee

There was no report from this Committee.

5. Tertiary Committee

Mr. Monsour advised that the Committee planned to present another Tertiary correlation chart to the Society for approval and also mentioned the possibilities of a field trip into the Alabama River Region.

6. Library Committee

Mr. Dennis discussed purchases and exchanges of books made during the summer months and future purchases that were planned.


7. A.A.P.G. Committee

Mr. Toler urged all members of the Society who were eligible for either active or associate membership into the A.A.P.G. to join. He advised he had application forms for those desiring membership.

At the conclusion of committee reports Mr. Stevens gave an up-to-date picture of the Sample Cut. He pointed out the need of additional facilities for storing, washing, and distributing samples and the need of increasing the present personnel of the Cut. After a general discussion of this problem, Mr. Harrell made a motion that a committee be appointed to work out a plan to eliminate the bottlenecks confronting the Sample Cut as it is presently functioning. The motion was seconded and unanimously approved.

Mr. Harrell's suggestion that more publicity be given in advertising meetings of the Society was met with unanimous approval.

MINUTES OF THE MISSISSIPPI GEOLOGICAL SOCIETY

A meeting of the Mississippi Geological Society was held the evening of November 6, 1945, at 7:30 P. M. at the Edwards Hotel. Forty-five members were present for dinner, and an additional fifteen were present for the paper.

At the conclusion of the dinner President J. B. Storey called the meeting to order. The following new members were presented to the Society:

Mr. Storey then introduced several out of town visitors and then asked for reports by the following committees:

1. Field Trip Committee

Mr. Spooner, Chairman, asked all those who intended to make the Alabama Field Trip to notify him at the close of the meeting. He advised that about 70 had signified their intention to go, and 130 to 140 were expected to make the trip.

Mr. Watson Monroe informed the Society that some new pre-Tuscaloosa section had been found in the Field Trip area and suggested time be extended to include a part of Sunday, December 9th, in

order to visit these outcrops. Mr. Monsour made a motion, which was seconded, to extend the trip to include Sunday morning, December 9th. The motion was carried.

2. Cretaceous Committee

Mr. Braunstein, Chairman, advised that the guide book for the Alabama Field Trip had been sent to the printer and would be ready for distribution by December 1st. The cost of this book would approximate \$500.00. A discussion on the price to be charged for the book followed, and while it was tentatively agreed to be in the neighborhood of \$3.00, the exact price would be set at a later date.

3. Program Committee

Mr. Wooley discussed future papers to be presented before the Society. He advised that Mr. W. J. Gillingham of the Schlumberger Well Surveying Corporation would deliver a paper on November 15th on the interpretation of electrical logs in Mississippi, and on November 28th Dr. Bailey Willis will deliver a paper entitled "Terrestrial Dynamics".

Mr. Watson Monroe suggested that the Society hold one meeting in December at Tuscaloosa; however,

no action was taken at this time.

3. Nomenclature Committee

Mr. Merrill Harris advised that in Clarke County, Mississippi, L. J. Roussell had completed the #1 Long Bell Lumber Company, Section 10-2N-16E, as a Butaw producer and that the Committee had designated "Quitman" as the name of this Field. This name was approved by the Society.

The "Galloway Dome" was suggested by the Committee for the V. H. Osmond #1 Anderson-Tully Lumber Company, Section 43-13N-3E, Warren County, new salt dome discovery. As another local name had been given this prospect by other companies, it was decided to await the official naming of this dome.

4. A. A. P. G. Committee

Mr. Toler stated that membership certificate for each member of the A. A. P. G. had been discussed among A. A. P. G. officers and asked whether the local members of the Association would favor this certificate. It was decided to await a later discussion on this matter.

Mr. Storey read a letter from M. G. Cheney of the A. A. P. G. requesting the Committee of the Mississippi Geological Society ^{be appointed} to discuss


standardized headings for electrical logs. Mr. Cheney asked for an early reply on the Committee's action. Mr. Clyde Alexander, Chairman of the Committee, read the letter of reply to Mr. Cheney, which was prepared by the Committee in conjunction with the Executive Committee of the Society. The gist of the reply was not to change the heading but to encourage the addition of usable data on the heading.

3. Sample Cut Committee

Mr. Harrell advised that nothing final had been accomplished regarding the handling and distribution of samples but reported some progress had been made.

At the conclusion of the committee reports, Mr. Storey introduced the speaker of the evening, Mr. Charles B. Hunt, U. S. G. S., Washington, Head of the Military Unit of the Survey. Mr. Hunt's paper, "Geology Applied to Military Intelligence", was very interesting and received favorable comment by most of the members.



Regarding the Alabama Field Trip Mr. Storey advised that a flat price of \$3.50 would be placed on the Guide Book. One concession was made, however, that any bona fide student geologist would be charged \$2.00 for the book. The Society was told that the first 200 books sold would clear the Society of the cost of printing, and the amount received for the rest of the books would be for the future benefit of the Society.

discussed the present operating cost of the Sample Cut
and asked that a meeting of the Sample Committee meet at
the close of the meeting.

Company, who gave a very interesting talk on "Interpretation
of Electrical Logs in Mississippi."

MINUTES OF THE MISSISSIPPI GEOLOGICAL SOCIETY

DECEMBER 7, 1945

The Mississippi Geological Society held its 1st December meeting in the Chemistry Building, University of Alabama, at 7:30 P.M., Friday evening, December 7, 1945. The meeting was held as a seminar the 1st evening of the Eutaw-Tuscaloosa Field Trip, held on December 9th, 8th, and 9th. President Storey called the meeting to order and welcomed the audience of about 100 that turned out for the seminar and the trip, particularly those from the Southeastern Geological Society at Tallahassee and those who had come from Dallas, Houston, New Orleans, and Shreveport for the trip.

The meeting was turned over to Watson H. Monroe of the U. S. Geological Survey who summarized the results of the work of himself, L. C. Conant, and D. H. Eargle, in the Tuscaloosa region, which results were incorporated in the guidebook of the Mississippi Geological Society.

President Storey introduced D. S. J. Lloyd, who, in the absence of State Geologist Walter Jones, welcomed the group to Alabama. Dr. Lloyd gave some very interesting historical notes on the early methods of working geology in Alabama, and on the early geologists of the State.

Following Mr. Monroe's talk a number of questions were asked by the audience. Tom McGlothlin then made a talk outlining some of his views, derived from his subsurface studies of these sediments, many of which views differed with the conclusions of the U. S. G. S. surface studies. Miss Louise Jordan then gave a resume' of the faunal evidence for divisions of the Upper Cretaceous as derived from studies of well samples and cores from South Alabama, Georgia, and Florida. A number of the other members of the Field Trip group had questions to ask and short comments to make.

The meeting was adjourned at 10:30 P.M., with instructions to assemble at 8:30 the following morning to resume the Field Trip.


5. Sample Cut Committee


4. Sample Cut Committee

MINUTES OF THE MISSISSIPPI GEOLOGICAL SOCIETY

The Mississippi Geological Society held a business meeting February 21, 1946, at 7:30 P.M. in the Edwards Hotel. The meeting was presided over by President J. B. Storey. Approximately forty members were present.

Mr. Toler announced that he had received a letter from Ira Cram stating that six hundred rooms in the Stevens Hotel were being reserved for the A.A.P.G. convention and that over five hundred of these rooms had already been taken. Three hundred rooms have been reserved in the Congress Hotel and two hundred rooms in other hotels. Mr. Cram suggested that reservations for the convention be sent direct to the Stevens Hotel as soon as possible and that the Stevens would refer any additional applications to the other hotels.

Mr. Braunstein, of the Cretaceous Committee, submitted a new Cretaceous correlation chart, which was discussed by members of the Society. Mr. U. B. Hughes made a motion, which was seconded and which passed unanimously, that the chart be adopted as the official chart of the Society and published in the Bulletin of the A.A.P.G. after deleting the words "Eagle Ford" after Lower Eutaw.

Chairman Toler, of the Core Display Committee, announced that his committee had decided on a core display if the Society could afford the show cases.

President Storey announced that Lyman C. Dennis, Chairman of the Library Committee, is being transferred to Wichita Falls, Texas, and that the Executive Committee had appointed Dick Priddy as chairman in his stead.

The motion was made, seconded, and carried unanimously that business will be discontinued at dinner meetings or when distinguished lecturers are present at the meeting. A motion was made, seconded, and carried by a majority of 21 to 7 that the regular dinner meetings of the Society be continued.

Mr. Max Bornhauser, of the Continental Oil Company of Lafayette, Louisiana, presented a very interesting illustrated talk on "Depositional Cycles of the Tertiary in the Mississippi Embayment". The talk was illustrated by a number of slides.

The meeting was adjourned at 10:15 P.M.



MINUTES OF THE MISSISSIPPI GEOLOGICAL SOCIETY


The Mississippi Geological Society held a meeting at 7:30 P.M., March 21st, at the Edwards Hotel. Approximately 55 attended.

Discovered by Roeser & Pendleton and Sohio's No. 1


Baker-Maier, Section 34-6N-2W.



MEMORIAL: ROBERT HENDEE SMITH

On March 26, 1946, Robert Hendee Smith, geologist for The Texas Company in Jackson, was killed in an automobile wreck near Delhi, Louisiana. Thus ended the career of a promising geologist, who was intensely interested in the geology of the Gulf Coastal Plain and the Mississippi Embayment.

Mr. Smith was born in 1916 in New York City, and spent his youth in that city, with summer trips to Europe with his parents. He received his preparatory schooling at the Kent School, and his college undergraduate training at Princeton. After receiving his B.A. degree there in 1938, he went to Louisiana State University for graduate work. "Smokey", as he was known, was an ardent naturalist, and went on many collecting trips. In his early years his interests were of a general nature, but they later became directed more and more toward paleontology. While at L.S.U. he visited most of the important Tertiary collecting localities on the Gulf Coast. For a time he was engaged in work on a problem in Walton County, Florida. He made an extensive collection of the Tertiary section of Little Stave Creek on the Hatchetigbee anticline of Alabama for the purpose of using it in a doctor's dissertation. This work was not completed, but he left a fine collection of this material, carefully labeled.

After completing two years of graduate work at L.S.U., Smith worked for a short time in the Paleontological Laboratory



MINUTES OF THE MISSISSIPPI GEOLOGICAL SOCIETY
EXECUTIVE AND SECTIONAL A. A. P. G. CONVENTION
COMMITTEE

A joint meeting of the Executive Committee and the Sectional A. A. P. G. Convention Committee was held in the office of J. B. Storey, Chairman of the Convention Committee. In addition to Mr. Storey, the Society President F. F. Mellen, Mr. Merrill Harris and the secretary were present.

Convention Chairman Storey outlined a telephone conversation with A. A. P. G. President Noble in which dates for the Sectional A. A. P. G. Convention to be held at Biloxi, Mississippi, were set for October 24, 25 and 26, 1946. These dates would fall on Thursday, Friday and Saturday. The tentative date was chosen to avoid any conflict with the November meeting of the A. A. P. G. which is to be held on the West Coast.

Hotels were contacted and the Buena Vista chosen as convention headquarters. The same management also operates the White House. The Biloxi and Tivoli Hotels are located within one-half mile and additional overflow can be accommodated at the Edgewater Gulf Hotel.

Between 750 and 1000 members are expected to attend the Convention and because of the large attendance anticipated and the resultant strain placed on the headquarter and nearby hotels to accommodate that number of members alone, it is suggested that all those planning to bring wives or families, make their reservations at the Edgewater Gulf Hotel.

Because of the general interest to others besides Association members which seems assured by papers arranged for the meeting, it was pointed out that Wednesday 23 or Saturday 26 might be arranged for S. E. P. M. and S. E. G. meetings, if either so desires. All details of their program would be left up to them.

Mr. Noble assured that the meeting will be sponsored and underwritten by the A. A. P. G., but urged that an effort be made to make the meeting as nearly self-supporting as possible. He pointed out that the greater part of the expenses involved would be in the printing of programs and for meeting rooms, and suggested that advertising space be sold in the programs and a registration fee be charged to help defray the expenses of the Convention. The registration fee to be charged was

tentatively set at \$2.50. He stated that Mr. J. P. D. Hull and a Secretary could come down to help out with the registration if necessary.

Mr. Noble also suggested that one-half day be set aside for a business meeting, and that thirty minutes would be all the time required for A. A. P. G. affairs, and the balance of the time could be used for the local society's business.

No entertainment has been definitely lined up, but it was considered advisable to have a banquet with tickets to the banquet to be sold when members register.
